

HOW MUCH DID THE PROPERTY COST?

The original purchase price of the 4 acre property including the 40,000 square foot building was \$3,000,000. St. B's was able to acquire a loan for \$2,300,000. The remaining \$700,000 was loaned to St. Benedict's directly by the owner of the property at 3.00%. The renovation of the building cost \$3,000,000.

PURPOSE OF THE GROW IN FAITH CAMPAIGN?

The Grow in Faith Capital Campaign is designated to repay the \$700,000 loan to the former owner of the property. The original plan was to utilize future real estate appreciation to refinance the entire purchase price. Unfortunately, timing was not on our side, and the real estate market stalled. Our beautiful piece of property continues to hold its value, but the \$700.000 note comes due in October.

WHAT IS THE ROLE OF THE DIOCESE?

The Diocese of Atlanta, under the leadership of Bishop Neil Alexander, has provided

abundant financial assistance over the years to plant the ministry of St. B's. From paying all the expenses the first two years, including WHAT IS THE salaries, office space and all the costs of worship supplies, the Diocese has been and

> continues to be generous and supportive. When the original loans were negotiated, the Diocese of Atlanta graciously agreed to guarantee the loans. However, it was always the plan and expectation that St. Benedict's would repay the debt from the generosity and faithfulness of its parish membership.

WHAT IS THE ROLE OF THE DAY SCHOOL?

The prosperity of St. Benedict's Day School has certainly helped the Church's financial stability. It has provided the means to service the debt (pay the interest) on our loans to purchase and renovate the property. The Grow in Faith Campaign is earmarked specifically for the \$700,000 principal payment.

2012 and beyond

WHAT IS MY ROLE?

We are currently paying \$21,000 a year in interest on this \$700,000... Next year, the interest rate on the note



increases to 10% and our interest payment would total \$71,000 in 2012. This figure represents 18% of the annual budget of our church! If this \$71,000 was made available, imagine the enrichment programs and outreach missions we could add to our parish life.

By combining our individual efforts, the branches of St. B's will be able to grow and deepen. Eliminating this debt will allow our mission and ministries to further spread the seed of Christ in the community into the future.

We must increase our collective share of ownership in the property to secure our future. In doing so, we strengthen the platform from which we reach out into the world.

The annual pledges that you have already generously offered are designated for the annual budget for the operation of the church. This funds the programs, the ministries, worship costs and the staff salaries of the church of which we hold dear.

The Grow in Faith Capital Campaign raises money specifically to repay a promissory note acquired to purchase the property. There are many ways we can direct our treasure.

One-time cash donations.

These help achieve our goal the most efficiently. As soon as we receive a check, we can reduce our debt and subsequent interest expense.

Two or three year commitments.

Sometimes we are able to make a larger contribution if we can make it over a longer period of time. You can make your

donation in one, two or three yearly payments.

Gifts of appreciated stock or bonds. You can transfer investments of stock or bonds without incurring a capital

gain. Just transfer the asset directly to the church account

Grow In Faith Campaign

Outright Cash Gift/ Campaign Pledge: We are asking that pledges be paid in full by December 2013. By allowing a three-year term for payment of gifts, many families can afford to make a larger contribution. Since our interest rate on the \$700,000 note increases significantly in 2012, we encourage accelerating these payments as much as possible.

Transfer of Securities: Many people find that donating appreciated stocks, bonds or shares in mutual funds can lead to a gift much larger than they thought they could give. An added benefit of this type of gift is that the income tax deduction is generally the market value of the security at the time of the gift, without any capital gains tax on the appreciation. Such transfers can be initiated by contacting Betsy Shuford in the Church office at 678-279-4302.

Stock Gift Example: You own stock that was purchased for \$7,500 and is now worth \$25,000. You give the stock to St. Benedict's and receive a charitable income tax deduction for the \$25,000 fair market value of the stock. In addition, you save capital gains tax on the \$17,500 appreciation. The benefit to the Church is the same whether you give cash or stock, the tax savings to you is likely to be greater if you give stock.

Planned Giving Opportunities: You may also choose to include the Church in your estate planning and receive significant tax and financial benefits. Some common planned giving vehicles include bequests, charitable gift annuities, charitable lead trusts, life insurance and retirement plan assets.

Donors are advised to consult with their own legal, tax and estate planning professional when considering gifts other than cash.

Other Creative Ideas

You might be wondering how you can possibly support a capital campaign when you are already giving all that you can to the Church for the annual stewardship effort. Following are some creative ideas that you may not have considered:

Ask your Employer about Matching Gift Opportunities:

• While many company matching gift policies exclude religious organizations, they will support educational programs, and capital funds were also used for the purposes of our Day School.

Make Gifts in Honor or Memory of Someone or Ask for Gifts in Your Honor:

- Honor a family member, friend, classmate, or faculty member with a gift in support of the campaign.
- Similarly, you could raise money for the campaign by asking family and friends to support this effort by making a contribution in your honor in lieu of gifts for a birthday, anniversary or Christmas. Consider offering this as a sacrifice to God in addition to your own personal gift.

Give Up Lunch or Dinner Out:

- By packing a lunch vs. eating out at a restaurant two times per week, you can give \$1,000 to the Church over the course of a year, or \$3,000 over 3 years: (\$10 / meal x 2 times per week x 52 weeks = \$1,048 / year).
- By spending an extra night eating dinner at home as a family vs. going out to a restaurant, you can give \$2,500 to the Church over the course of a given year, or \$7,500 + over three years: (Dinner for 4 @ \$50 x 52 weeks = \$2,600/ year).
